 - Motion to accept list of delegate candidates by Justin Costa, seconded. Motion carried unanimously
- Democratic candidates for District Attorney (Seth Levy, John Gale, and Frayla Tarpinian) made brief speeches and held an informal Q&A session with the membership.
- Review of Block Captain program (what it is, how it works, the goals), announcement of upcoming training
 for the program from Sarah A. The suggested design is for PDCC block captains to connect with thirty
 registered Democrats in their neighborhood-voting district. Interviewing and meeting with these neighbors
 will foster local community building as well as concrete actions and support for effective voting. This
 month, the PDCC will train prospective block captains.

- Motion from Gwynne Williams to amend bylaws to amend Article III Membership, as follows.

Section 1. Methods of Qualifying for Membership.

Any resident of the City of Portland who is a registered member of the Democratic Party may become a member of the City Committee by either:

a) being on record as having attended the Portland Democratic Biennial Municipal Caucus, or....

Motion from Gwynne Williams to amend bylaws to remove Section 5 from Article VII – Executive

Committee, which currently says:

Section 5. Selection of Subcommittee Members. The Executive Committee shall select members of the standing subcommittees.

and to add Sections 4 to Article III, Membership, as follows:

Section 4. Subcommittee Membership.

All PDCC members are de facto members of all PDCC subcommittees.

Justin Costa motioned to amend the motion to strike the words de facto. Motion to amend passed unamimously by hand vote.

Motion passed unanimously by hand vote.

Motion from Gwynne Williams to amend bylaws by adding the following section to Article III:

Section 5. Contact Information.

- (a) Contact information for all PDCC officers and subcommittee chairs, who shall be provided with PDCC member email addresses, shall be posted on the PDCC website.
- (b) Access to and use of the PDCC email list shall be restricted to PDCC officers and subcommittee chairs doing the business of the PDCC.

Motion tabled with unanimous consent.
