- Special election for both positions will be held next month, on August 9, probably at City Hall but TBD. More announcements will follow.
  - Special election will only fill those positions until the term is up, which expires after November election

## Plan November campaign

- Overview by Sarah A
  - Governor is biggest race
  - CD-1 and CD-2
  - US Senate
  - RCV will be used for federal races, but NOT for governor or state legislature
  - Will be opportunities for work in Portland, across the state, and virtual (phones/texting/etc)
- Isa, Portland / South Portland organizer for Maine Democratic Party
  - Introduction
  - 7/29 marks 100 days until the election
  - Focus is on low-propensity voters (vote in presidential years, but not in mid-terms)
- Breakout into groups
  - Direct outreach to Portland voters
  - Block captain program
  - Recruitment
  - Swing seats
- Kate McLellan from Maine Democratic Party Coordinated Campaign
  - Introduction
  - Mills, Pingree, & Golden are members; Ringelstein is not (could change)
  - Focuses include ID work, determining what issues drive people
  - Commit to vote cards - sign now, get mailed back right before election

## Bylaws amendment

- Summary
  - Introducing possibility of having co-chairs
  - Introducing possibility for officers to temporarily hold two positions, in case there are not enough candidates to fill all seats on short notice
